Dear parents, carers and students,

Great Marlow School is required to adhere to the Joint Council for Qualifications (JCQ) General Regulations for all examined and non-examined assessment. For the academic year 2024 / 25, this states that:

Schools must inform candidates of their centre-assessed marks for non-examined assessment (NEA) as students will be allowed to request a review of the marking before marks are submitted to the awarding body. The review should be of the mark that has been awarded, confirming whether [it] is in line with the standard set for other candidates at the centre.

Students will be told the mark that they have been awarded for any work that contributes towards a final public examination grade and that has been marked by GMS staff (an internal assessment). The mark will have been awarded in accordance with JCQ guidance. The latest dates that students will be notified of these marks are in the tables at the end of this letter.

Students have the right to request a review of a given mark if they feel that the marking criteria or procedures have not been correctly applied. Please make sure that you read our 'Internal Appeals Policy relating to internal assessment decisions' carefully, as this outlines the process that a student must follow if they decide to request an internal review. A copy is on the website under Learning - Examinations Information – Exam Results, Appeals and Resits. If a student is concerned about a mark, we recommend that they speak to the Head of Department about this first.

If a student, following discussion with the Head of Department, would still like to consider a review of the marking, they need to:

- 1. Email exams@gms.bucks.sch.uk (from their GMS student account) to request copies of the relevant marked work deadlines for requesting this material are in the following tables.
- 2. Students can use this marked work to decide if they still want to request an actual review of the marking. If they do wish to request a review of marking, they must complete the relevant form (again, on our website under Learning Examinations Information Exam Results, Appeals and Resits) by the deadlines outlined in the following tables.

Emails or forms received after the deadlines published in the tables will not be processed.

Prior to submitting a request for an internal review, a student should consider the following:

- Marks can be adjusted up, down or remain the same at any point of the internal review process.
- The mark is still subject to an external review by the awarding body. This means that marks can be adjusted up, down or remain the same at any point in this external moderation process also.
